### **Product description**

Circular spiral ducts and duct component made of metallized sheet steel as below: Hot-dip galvanized steel plate with the designation DX51D + Z275 according to EN 10346. Surface coating with Z275 meets corrosivity class C3 according to AMA VVS & Kyla 22 and SS-EN ISO 12944-2.

Duct components are provided with seal rings of EPDM rubber.

### **Dimensions**

The Swedish technical approval includes dimensions 63 - 1250 mm according to dimension standard EN 1506. Plate thickness ducts:

### Suspension/fastening/pendulum bar

The ducts shall be provided with a suspension of max 500 mm from each joint and the maximum distance between uninsulated duct hangings is 3000 mm and for insulated ducts 2000 mm.

### Intended use

Circular ventilation ducts for distribution of air with demand for air tightness class D in buildings.

### **Basis for approval**

Test reports P107584-21B and P107584-21C from RISE and inspection reports AO-0007040, P107584-21A, O100177-1109085A, AO-0006973 and 1157686-01A.

### **Comments**

The products are tested according to EN 12237 with the headline: "Ventilation for buildings – Ductwork – Strength and leakage of circular sheet metal ducts". The ducts fulfill tightness class D at +2000 Pa overpressure and -750 Pa negative pressure and strength requirements.

Associated documents shall accompany the product or by other means be available to users of the product.

This type approval supersedes the previous type approval with the same number dated 2018-02-22.
